After a mistake on his part, the Reverend's ministry is put into question and his status as a leader within the church is removed as a result of a false accusation, the author must go on a journey to learn the laws of the church and fight for the truth as he makes amends for the mistake that began this nightmare and forces the truth out of the darkness and into the light.

The author did a fantastic job of crafting the perfect balance of faith and religion-based discussion with personal experience within the Methodist church and the legal system as a whole. The painful and intimate way the author examines his own precluding actions and acknowledges his mistakes was a refreshing change of pace for a narrative of this stature, as the author was able to separate the wrongs done to him while still owning up to his decisions to enter into a relationship outside his marriage that led to these complaints with the church.

This is the perfect read for those who enjoy non-fiction memoirs with a hint of religious and spiritual text, and personal stories of fighting for truth and justice. One

thing which really stood out was the way the author was able to incorporate documentation and legal discoveries regarding the rights of those within the inner structures of the United Methodist Church. The way the author was able to give so much detail regarding the experiences he had within this process showcased the rarely seen behind-the-scenes stories of organized religions and the politics that go on behind closed doors.

There is a high possibility that every one of us will experience problems that will shake us or negatively affect us, no matter how small or big. These could come from financial problems, emotional problems, health problems, or even relationship problems. How do we deal with these problems when we are faced with them? If we make mistakes in the course of dealing with these problems, are these mistakes ones that we can easily be dug out of?

In Stolen Grace: How God Rescued Me from the Jaws and Claws of the United Methodist Church, Rev. Errol E. Leslie recounts his experiences with the United Methodist Church. The author is confident that his call to ministry is a genuine call from God as he uses a story recorded in the Acts of the Apostles, Chapter 5, to explain. However, does a genuine call from God assure a smooth road? Rev. Leslie is put to the test. Does he succumb to temptation?

I honestly enjoyed every single thing about this book. Even though it was a non-fiction book and one that dealt with hearings in a church, I felt at certain times that I was the judge, going through the evidence, reading documents presented before me, and wondering what the author deserved. This was the effect that the author's inclusion of these documents had on me. I liked how the documents and reports contained dates, especially those of the Reverend's wife. It helped display the credibility of the story, and testimonies from individuals helped to show that the author was not just trying to clear his name but that, indeed, he was telling the truth.

The book talked about a wide range of things, which was pleasant. It discussed struggles in marriages and the importance of communication and change in marriages. By reading this book, I learned that partners should be able to not only listen to the complaints of one another but effect changes in the necessary areas to

maintain relationships. I was saddened by the fact that the injustice the author faced was done by people who were called to serve God and in a place that should supposedly be the home of forgiveness, love, and a nonjudgmental space. It was so painful to see how the author suffered based on false accusations by a woman and a church unwilling to carry out necessary investigations. His fate had already been decided before a trial even commenced. I love the author's persistence and how he maintains his call even after all the struggles. This quality is worthy of emulation and one that would be helpful in our lives. There were also different stories or testimonies in the book that house strong themes like physical and sexual abuse. The author's mistakes teach us to seek solutions in better places, and I appreciate that he acknowledges his mistakes.

The thing I liked least about this book was the fact that it seemed we were hearing from just one of the parties. Although the book seems packed with evidence corroborating the author's side of the story, for fairness, I would have appreciated hearing more from the other party too. The author who was born in a small village in Westmoreland on the island of Jamaica grew up and discovered his passion in the church which he termed a calling from God.

In this memoir, Stolen Grace by Rev. Errol E. Leslie, he narrated how he was 'persecuted' in the hands of the United Methodist Church where he served as a Reverend in Palm Bay Florida. The author uses interesting quotes from the bible to relate and describe his situation at the "ruthless" hands of the united Methodist authority that punished him for a mistake humanly erred by himself.

I would equate the plight of the author to have landed in the hands of 'Jezebel' from the biblical scriptures. The author kept my curiosity at par in suspense as he began the book with his plight and revealed how he erred in the later chapters of the book. I also enjoyed how the author related his story to the scriptures going further to even liken some of the characters in his story to characters from the bible. First, he relates his temptation and fall to that of David from the Bible and narrates how he expected the church to handle his issue with grace. However, this was never the case. Secondly, he related some of the heads of the clergy handling his trial with a hardened and ruthless heart to the pharaoh in the time of Moses, the pirate in the persecution of Jesus, and the characters in the parable of the Good Samaritan.

Leslie is a personal account of one man's struggle against an unexpected, monolithic foe in the form of the very institution in which he carried out the calling on his life. True perfection, in any regard, is out of the realm of possibility for any man; we can only at best strive towards it and hopefully find the best versions of ourselves. This is often done by adopting a religion, a philosophy, a code of conduct or some other teaching believed to be greater than our limited wisdom. However, whatever the path you may adhere to, I think we all can agree that mistakes are an inescapable part of life; one can only ask that enough grace be extended to them so as to not be buried by the weight of their transgression, so as to one day rise anew. In this 517-page memoir we get a detailed portrayal of Rev Errol E. Leslie's battle to retain just that.

Was not sure what to expect going into this book as it was my first time reading a memoir and honestly, I thought how interesting could a Pastor's autobiography be, even if it did involve some form of scandal? I am surprised to say it gripped me more than I expected, even if only slightly. The way how he presented the actions of the United Methodist Church both enraged and annoyed me all while being reminiscent of a secret sinister organization from an old television series. All this while making you question if there was some ulterior motive and if their actions towards Rev Errol E. Leslie was just a misdirect for something deeper. I also admired how the Reverend's character shinned through, that even after having gone through what he did, his depiction of these series of events was not deliberately disrespectful to those involved.

That being said, after the first few chapters this read was still a slog to get through. It became repetitive to the point were at times I thought I had made a mistake and was reading a past chapter again. The extensive use of legal jargon and several testimonials did not make it any easier either, as at times I wondered if I was reading a memoir or studying for a law degree. Also, the letter was barely legible, I would have appreciated if it was type as well as show in the book. Though I due understand

that these legalities were an important part of his depiction of these events, the detail in which it was presented felt like unnecessary padding and almost drowned out the message of the book. Also, though Rev Errol E. Leslie does have my sympathy for what he went through and he comes across as penitent for his role in all of this, something just feels off about it. Yes, the actions of the United Methodist Church are at the very least questionable but his fault in all of this seems too downplayed. Though I guess that is par for the course with personal accounts.

So, after some careful consideration, I have to hand down a rating of 2 out of 4 stars. I wanted to like this book more as he is native to my country and we are of the same religion but I believe it was over written and honestly, I felt more sorry for those who got caught in the cross fire, such as the family and congregants, than the Reverend himself. Just to clarify though, I do understand where the author is coming from, bearing his soul to present his side of the story after he, his family and members of his congregation were put through such a grueling and public ordeal. So, in that regard I appreciate Stolen Grace for what it is.

Not trying to be cynical but I believe this book would be a good read as a case study for anyone involved in law, whether as professional or just an enthusiast. Also, it definitely should be required reading for anyone in or considering pastoral work or anything of a similar capacity to act as a reminder of the weight of such a role. In Stolen Grace: A Memoir: How God Rescued Me from the Jaws and Claws of the United Methodist Church by Rev Errol E. Leslie tells the story of his call to ministry and how his life and work in the United Methodist Church was terminated by a mistake which the leaders of the church decided was unforgivable.

The book begins with the author sharing how he felt a call to ministry since his teenage years. Moving from Jamaica to the United States, and how, after years of service to the United Methodist Church and the Methodist Church in the Caribbean and the Americas.

The book is very relatable, the reader does not need to be religious, or a minister to understand what Rev. Errol E. Leslie was feeling and sharing throughout the book. Rev Errol opens up and discloses how emotionally lonely he felt, and how different aspects of his life made him realize he was not as appreciated as he thought. He even shares details of how complicated and unhappy marriage can be, but we do not need to give up or give in to the desire to find temporary happiness. However, as relatable as the book is, when it comes to human mistakes, I also found the author annoyingly blaming everyone else without admitting his fault in the issues. I understand that he is telling his side of the story, but in my opinion, he is telling is playing the role of the victim, he was taken advantage of by the church, and by his "friend", and he couldn't defend himself on what he admitted. I also felt that he did not regret having an affair.

While this is not necessarily something negative, the author quotes the Bible often, which some readers might not like. I do not think this makes the book only suitable for religious readers but is worth mentioning. He also included a handwritten complaint sent to his district superintendent, but I would have appreciated it if he

shared a transcribed copy, as I found it hard to decipher what was written. This letter has a very important role in the author's memoir, and I feel like I lost important information. My only explanation for not doing this is that the author did not want the reader to understand it, and wanted to control the narrative, and the content. I also found the book overly repetitive, with the author saying, again and again, the same things and facts.

I believe in hearing both sides of the story, and that we need evidence to determine the truth as best as we can. Unfortunately, this book does not allow the reader to do that, as we only get his side of the story, and as unjust as the trial was for the Reverend, it would be unjust to assume that everything the complaint said was a lie. While I do not believe everything, she said was true, I cannot say it was all a lie or exaggerated. The only thing I can do is follow the author's message and not judge either party involved in this story.

Overall, I rate this book 3 out of 4 stars. I had trouble with this rating. While I cannot rate the book based on my perception of the author's character, I do have to consider if this book would have been nicer if I did not dislike the author. The truth is my rating would not have changed. The book is overly repetitive, and the complaint letter should have been transcribed, but it is also honest and real. In a moment of weakness, Rev Leslie made a mistake that cost him his livelihood, his home, and all his privacy. He was not given a fair chance by the board to plead his case, and the person who lodged the complaint against him scandalized his name.
